1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Managed and nurtured by philanthropic Trust Sardar Vidyabhavan, Shri V. R. Patel College of Commerce, Mehsana was established by a visionary named Shri Balrambhai Kshatyitriya in the year 1964 as Municipal Arts and Commerce College. This college is named after Shri Varanasidas Ranchhoddas Patel who donated a huge amount in order to establish this college and hence the name of the college is Shri V. R. Patel College of Commerce, Mehsana. It came into existence as a separate commerce college on 15th June, 1986 with the motive of imparting high quality education in the emerging and occupational areas of trade and commerce.

The college is co-educational institute recognized by UGC under section 2(f) and 12 (B). It is affiliated to Hemchndracharya North Gujarat University, Patan. At present the college follows NEP 2020 as per guidelines provided by Hemchndracharya North Gujarat University, Patan. The college offers Under-Graduate, Post-Graduate, Vocational Programme (B. - The college has introduced 15 new certificate/diploma programs and 28 Short Term/Value added Courses to impart life skills during last 5 years.

Recently we have also implemented RFID (Radio Frequency Identification) system in our library.

New Arrivals on Display:

The Library announces the new arrival of books on new arrival display screen. New arrival display service will inform patron about books processed on different dates during the previous month or week. The Library also announces newly announced government and reputed companies' requirement notification on New Arrival Display screen placed at entrance of the library.

Self-Issue-Return Kiosk.

Library has been equipped with RFID system providing self-issue/return/renew of books using Kiosk. Library users themselves can issue/return/renew the books. This service will be operational during the library hours. The users can use the Kiosk in the library for this service themselves. After issue or renewal of books through the Kiosk, a print receipt will be issued at the Kiosk.

Library RFID Smart Card:

Library is offering RFID-enabled Library Smart Cards to the Registered Library Members. Smart Card will help users to track their library account and save their time while using library services. The library is using MIFARE card too.

Smart Card Printer:-

Library has a smart card printer. We have printed all smart cards in the library, so we can issue cards to the students as earlier as possible. If any student's smart card gets damaged or lost the librarian issues him/her a new card without much delay.

Software for smart-card:-

Library has purchased Cardpresso software for creating smart-cards.

Book Drop Station:

Our Library has initiated a Book Drop Box facility for returning library books. The book drop station has been placed at the entrance of stack room. This is to facilitate easy return of issued library books by just dropping the books inside the drop station. This is RFID-based Drop Box facility where the user can drop the issued book at the RFID Drop Box himself/herself and the software gets the book back automatically and the user receives a book return receipt from Drop Box immediately.

Staff Station:

Staff Station is also RFID based services. It allows Library users to issue/return/renew the books at circulation section. This service remains operational during the library hours. We have just to put the smart card on it or book and staff station detects the history automatically and displays it on Middleware software.

6.3.1

1. PERFORMANCE APPRAISAL SYSTEM:

- **Appraisal for Non-Teaching Staff:**

- Major work for all non-teaching staff is administration.
- For the up gradation of their administrative skills, the college allows non-teaching representative for getting trained in particular administrative areas such as Tally-Accounting , Finance, Academic Bank of Credit (ABC) of students, Online Student Enrollment, Online Pay Scale, Preparation of Retirement Report, COGENT-Government Employee Portal, Online Fee Payment, Online Result Declaration etc.

2. EFFECTIVE WELFARE MEASURES FOR TEACHING:

- A registered Credit Society is run by Sardar Vidyabhavan Trust for the benefits of teaching and non-teaching staff and all other sister-concerned colleges on the campus. The loan to the tune of 15 lakh can be procured from the credit society. All the permanent employees of the colleges on the campus are the members of the society. The Credit Society is engaged in the following activities:
- Awarding prizes to the wards of the members for their outstanding performance in academic fields.

- Paying 500 rupees every year to the children of all the peons for purchasing books and notebooks.
- Distributing sweets to all the members of the society during the festival of Rakshabandhan.
- Organizing farewell functions for the retired members of the society.
- Paying Rs. 21,000 in the event of death of a member.
- The college exempts the children of staff members from educational fees.
- In the admission process, too, priority is given to the children of the staff members so far management quota is concerned.

3. EFFECTIVE WELFARE MEASURES FOR NON-TEACHING:

- The college also provides monetary help to the administrative staff by giving them each Rs. 1000/- for dress, Rs. 200/- for shoes, Rs. 500/- for yearly washing allowance, Rs. 150/- for an umbrella etc. every year. A cycle is given to a peon who is supposed to shoulder the administration-oriented responsibilities outside college campus.

4. AVENUES FOR CAREER DEVELOPMENT/PROGRESSION

6.4 Financial Management and Resource Mobilization

6.4.1

- Various proposals forwarded to UGC, NAAC, and other Government and Non-Government agencies
- Research cell of the college provides funds given by Research Agencies for research papers
- The Alumni Association provides financial support for various activities.
- The funds are effectively utilized for the purpose for which it is granted and the income and expenditure are properly audited and filed.

OPTIMUM UTILIZATION OF FUNDS IS ENSURED THROUGH:

- Sufficient funds are allocated for effective practices. Enhancement of library facilities needs to augment learning practices and accordingly requisite funds are utilized.
- RUSA Grant supports SC/ST/Minority students for free book sets from the library worth Rs.40/-.

- The college gives the whole book sets to all other students charging only Rs.20/- from each.
- Every year the college receives grant amounting to Rs.5, 00,000/- under the head of Finishing School Training from Government. Every year college more than 150 students get benefitted from this grant in order to become employables.

INTERNAL AUDIT:

Accounts are prepared by the Office Superintendent (OS). The accounts get audited by the chartered accountant regularly as per the government rules at the end of each financial year. The auditor ensures that all payments are duly authorized after the audit. The audited statement is duly signed by the Principal and the C. A. The internal audit is carried out regularly.

External audit: The External assessment is carried out by the CA named Mr. Ashvin K.Yagnik. The detailed report is submitted every year.

Optimal Utilization of other Resources: Optimal utilization of available non-financial resources is done at the campus through prior proper planning. The optimal utilization of classrooms and laboratories is ensured through encouraging innovative teaching and learning practices. The available physical infrastructure is optimally utilized. The Library Advisory Committee takes care that the resources in library are utilized optimally. Books and other reading materials, sought through research grants, are stored in the library. Instruments, purchased through, MRP are used in the departmental laboratories. The central auditorium of the college is used for various curricular, co-curricular, extra-curricular activities. The college infrastructure is utilized for conducting Government examinations. Teaching and non-teaching staff get benefitted by the computer lab and DELL. Gym can be utilized by both the staff and the students. The auditorium and play grounds are also utilized by the members of the community as well.

They are motivated by providing necessary ICT tools and infrastructure. During COVID-19, the teachers made use of Online platforms like MOOC, YouTube, Google Classrooms, Zoom, Google Meet, WhatsApp, Telegram and institute's LMS etc. E-content has been developed by faculties in the form of videos and PPTs, PDFs etc. Library software SOUL has been upgraded to version 3.0. Web OPAC facility and N-list programmes are provided to the students and teachers. The faculty members are encouraged to participate and conduct seminars, workshops, group discussions, viva-voce etc.

2. Completion of Syllabus: The Academic Calendar is prepared at the beginning of the every academic year and circulated among the staff. Annual teaching plan is prepared by the concerned departments and implemented. Monthly report of completion of syllabus is collected and verified.

3. Exam reforms: IQAC gives necessary directives to internal Exam Committee and faculties to conduct and evaluate internal assessment. As the institute is affiliated to HNGU the final exams are conducted as per the university schedule. Most of the teachers of the institute are involved in **the** entire exam procedures i. e. paper setting and assessment.

7. ANTI-THEFT PART OF THE LIBRARY RFID MANAGEMENT SYSTEM AND FOOT

FALLS COUNT APPLICATION:A security gate on library entrance restricts movement of unchecked item by giving alarms.Gates is the anti-theft part of the Library RFID Management System using the same RFID tags embedded in the library items.Each lane is able to track items of about 1 meter and would trigger the alarm system when an un-borrowed item passed through them. The alarm will sound and lights on the gate will flash as patron passes through with the un-borrowed library material. Our Library security systems ensure that foot falls in the library easily get recorded with inbuilt people counter at the RFID security gate in library.

8.STUDENT SELF OPERATED LIBRARY AUTOMATION FOR ISSUING AND RETURNING BOOK:-

- 1.New Arrivals on Display:**The Library announces the new arrival of books on new arrival display.New arrival display service will inform patron about books processed on different dates during the previous month or week.The Library also announces newly announce government and reputed company requirement notification on New arrival display.New arrival display placed at entrance of the library.
- 2.Middleware software for operating this RFID system:**We have upgrade our library with SOUL 3.0 software.Recently we have also implemented RFID (radio frequency identification) system in our library.We have installed Middleware software for operating this RFID system.
- 3.Self-Issue-Return Kiosk:**Library is equipped with RFID system which provides self-issue/return/renew of books using Kiosk.Library users can issue/return/renew the books by themselves.This service will be operational during the library hours.The users can use the Kiosk in the library for this service. After issue or renewal of books through the Kiosk, a print receipt will be issued at the Kiosk.
- 4.Library RFID Smart Card:**Library is offering RFID enabled Library smart card to the Registered Library Members.Smart Card will help user to track their library account and save your time while using library services.We are using MIFARE card. MIFARE is a contactless card technology.Student has to just put their smart card on KIOSK their details automatically show on KIOSK screen.Our smart card is student Id-card and Library card.It's a combo card for students.So when the student takes the admission in our college and we give them Id-card they will automatically become member of our library.
- 5.Smart Card Printer:**Library have smart card printer.We are printed all smart card in library so we can issue card to the students as much as faster.If student smart card is damaged or lost we can issue him new card at a time.
- 6.Software for smart-card:-**Library has purchased Cardpresso software for creating smart-card.
- 7.Staff Station:**Staff station is also RFID based services.Its allow Library users issue/return/renew the books at circulation section. This service will be operational during the library hours. We have to just put the smart card on it or book and staff station detected automatically and show it on Middleware software.
